## **Town Board Meeting**

# Wednesday, May 12, 2021

A regular meeting of the Howard Town Board was called to order by Supervisor Donald Evia at 19:00. Roll was called and Councilmen present were Richard Stewart, Lowell Smith, Eric Hosmer, and Gary Rice. Lee Pyer Highway Superintendent was present. <u>Previous minutes:</u> Reviewed. Motion to accept April 2021 minutes by Councilman Rice, second by Councilman Stewart. *Carried: Councilman Stewart aye, Councilman Smith aye, Councilman Rice aye, Councilman Hosmer, abstain, Supervisor Evia aye.* 

<u>Public Comment:</u> There was general discussion regarding the Windmill Project with comments from multiple community members. Barry Kidder read a prepared statement (under separate cover.) Allan Mantell spoke. Joanie \*\*\* spoke. Statements were also given by Chris Linton and Bob Wagner. There was much dialogue among the group.

**Old Business**: none presented.

**New Business:** Councilman Rice presented the first quote for coating the Highway Building Roof (\$43,000.00) Will be seeking additional quotes.

<u>Highway Report</u>: Lee Pyer presented an updated 284 Agreement for signatures – signed by Board members. Under file in the Clerk's Office. Mr. Pyer noted that gravel levels are low and the department will begin crushing soon. There was discussion regarding extending the gravel allotment by 5,000 ton to a total of 25,000 ton. There was dialogue regarding the paving of roads versus oil / stone and the maintenance programs of each method.

Discussion about the purchase of a new lawnmower was tabled at Mr. Pyer's request. The new roller will be delivered in September. Highway report filed under separate cover.
